Autism Spectrum Disorder (ASD) is a diagnosis that has gained increased attention over the past few decades, largely due to the rapid increase in cases. According the latest CDC numbers, 1 in 54 children has an ASD diagnosis. This is a lot of children and adults that need services! While many people think that people with ASD only need disability specific care, such as Applied Behavior Analysis (ABA), nothing could be further from the truth. Children and adults with ASD have high rates of co-occurring mental health disorders such as anxiety, depression, and PTSD.

Unfortunately, people with ASD face barriers in accessing the mental health care that they need for these conditions. While there are many complex reasons that people with ASD struggle to obtain needed care, one component of this problem is that mental health care providers often feel they are not qualified to treat these clients. In this presentation participants will learn about ASD, debunk common myths about people with ASD and therapy, and begin to build the confidence and competence to provide essential mental health care to this population.

<u>Haleigh Scott</u>, Ph.D. is a licensed clinical psychologist specializing in assessment and treatment of people with developmental disabilities and co-occurring mental health disorders. Haleigh is currently Assistant Professor at California Northstate University and owner of a small private practice. She graduated from The Ohio State University in 2016 with a Ph.D. in Intellectual and Developmental Disabilities Psychology and completed postdoctoral training at the University of Illinois at Chicago and the UC Davis MIND Institute.

Dr. Scott started <u>Ascend Diagnostic and Support Services</u> to provide services for disabled children and their families throughout their lives.

What You Missed Gina Culver

On February 6th, Diane Gleim, LMFT, CST, CST-S (www.dianegleimMFT.com) presented "Porn and Relationships: Taking a Sex-Positive Approach." Diane explained what pornography is and is not, what the issues are, how pornography impacts clients, and how to work with both individuals and couples. She defined what pornography is, other related terms, and explained the different types/formats of pornography. One point that Diane shared is that porn is



"not addictive, it does not cause erectile dysfunction (ED), is not sexual education, and is not real." She also shared what pornography can be, "a form of entertainment, satisfy curiosity, a vicarious experience, solo

sex/sexuality, or to enhance arousal between couples."

A common problem with porn, especially free porn sites, per Diane, is that it is made for "the cis straight guy" and does not reflect everyone (e.g., women, gay men, lesbians, POC). Diane emphasized that "how we talk about something matters" and encouraged to not say "using porn" but rather, say "view or watch" porn. She informed that "language creates reality and labels." Diane shared some research concluding that there is "no evidence of porn consumption being either adaptive or maladaptive when it comes to relationship closeness or loneliness."

Diane discussed "moral incongruence" and "erotic conflict" being the problem issues with porn rather than addiction. She defined erotic conflict as "I like X and I shouldn't like X." She also shared that there are populations that don't have problems with porn: "LGBTQ+ individuals and couples" though research is lacking for POC. Diane reiterated several times throughout her presentation that if a client is reporting use of illegal porn (i.e., child pornography) that is a mandated reporter report. She shared that there are ethical websites and that the free porn sites are for profit and not as ethical as they do not demonstrate asking for consent, as one example she gave is that on CAMFT's website, one can search "sex" in EBSCO host and get a list of articles and research for further reading (camft.org/Education/EBSCO).

Diane informed that when working with individuals and clients (second half of her presentation), the question to ask is "what was behind the decision?" In this framework we choose, "sitting with them [clients] in their pickles" and "not fill in the blanks." She encouraged to explore with them, be curious about their motivation and sexual decision-making, and help clients "to decrease their sexual shame." Diane shared vulnerabilities that contribute to "problematic porn viewing" – what to assess for when working with clients. One point Diane stated when working with couples is to not reinforce the accusing partner, as "we are set up for triangulation" and we are seen as the "fixer or rescuer." Our role is to "help them identify relationship agreements about sex." Diane also discussed "solo sexual," both for individuals and within a relationship.

Watch the recording for the in-depth information Diane provided. Clients want to be able to talk about sex as it can be an issue for them. In my experience, many therapists shy away from the topic, especially when porn is involved, as it is uncomfortable. I found that this training provided me with more confidence to discuss the issue, or to refer out if it is too complicated for me, without judgment.

Check out Diane's blog on Psychology Today, "Underneath the Sheets." Diane is available for consultation in addition to trainings and supervising sex-therapists-in-training.
